4) Declaration by the parent/Guardian

1. I have read the Rules and Regulations mentioned in the prospectus of the School and hereby agree to abide by them.
2. I agree to pay the prescribed school fees in advance and agree to pay any fine levied by the Principal and interest for non-payment of dues in time.
3. I note the norms of the cancellation of admission i.e.
 - a) Students leaving within one month.
 - i. That a student would be charged full amount of admission fee, term fee, laboratory fee and tuition fee.
 - ii. That the student would be charged actual store bill.
 - iii. That caution money would not be refundable.
 - b) That there shall we NO REFUND OF ANY FEES for student leaving after one month, except caution money.
4. I note that I have to give notice for withdrawal of my ward one month in advance. I understand that School Leaving certificate will not be issued unless all school dues are settled.
5. I declare that whatever my religion is, I have no objection to my son /ward in attending the school prayers and functions.
6. I agree to my son/ward being provided with urgently required articles and equipments, the cost of which will be charged to me in the bills.
7. I agree not to ask for special leave for my son/ward or visit the school against regulations.
8. I agree to pay all bills regularly and accept the rule that my son/ward is liable to be sent home if bills remain unpaid.

I agree that school authorities shall not be liable for any damage or charge on account of injuries to my son /ward any time during his stay in the school while taking part in sports or other co-curricular activities .I understand that I am liable to pay for the damage or injuries caused by my son/ward.
10. I agree that in all matter of dispute, the decision of the Principal shall be binding on me.
11. In accordance with the School Rules, I authorize the participation of my son/ward in compulsory programs of tours, treks, expeditions, camps etc. during his stay in the school.
12. I also authorizes the Principal and through him the Staff of the school, to act as local Guardian of my son/ward when he is in the school or on tour, expeditions, camps etc.
